Campanella and Moore Bring a Combined 40 Years of Leadership Experience to On Lok's Senior Executive Team

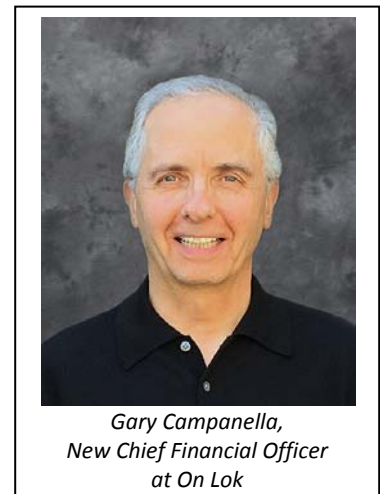
